These funds will be used to pay FireShows West conference registration fees, lodging, travel expenses and per diem for up to 15 responders in Nye County. Nye County LEPC Secretary/DEM Administrative Assistant Patrick Lazenby will make all travel and lodging arrangements as well as conference registration for all attendees. Patrick will also prepare and submit all travel vouchers and submit to the Nye County Finance Department for reconciliation and payment. Nye County Finance Department/Grants Administration will submit requests for reimbursement (RFR) to DHS Grants, with necessary documentation, for reimbursement to the County. This activity will be implemented upon receipt of notice of grant approval from Nevada State Emergency Response Commission, and acceptance by Nye County BOCC; all travel vouchers will be submitted within 30 days of completion of travel and RFR submitted to DHS Grants within 30 days of payment to attendees.

#### **BUDGETS:**

#### Training:

All training requests must first be made through the State Fire Marshal's office (SFM) and the Department of Emergency Management (DEM). If the SFM or DEM declines the training, the request may be included in the grant application along with the letter of declination.

All expenses must be itemized. State per Diem rates (which generally follow the federal GSA rates; (http://www.qsa.gov) will prevail unless local/negotiated rates are less. Hotel receipts are required for all lodging reimbursement requests, including in state lodging. Meals included in registration fees will not be reimbursed. Travel eligibility requirements and rates are further defined in SERC policy 8.5.

Requests for a consultant/contractor to provide training must be accompanied by at least two competitive bids. The bids must include an itemized quote and detailed scope of work from the consultant/contractor.

If a privately owned vehicle is used for agency convenience, mileage may be reimbursed at the State rate, currently .575 cents per mile. Nye county is a very large, rural county that covers over 18,000 square miles. One of the main HAZMAT transportation corridors in Nevada goes directly through Nye County. Due to the rural location of our stations and the fact that outside of the Town of Pahrump, all responders are volunteers, training is not as accessible and readily available as we wish. FSW has consistently provided a viable solution to this problem. It is a training that responders enjoy attending to earn CE hours, network with other responders and learn new techniques. Attendees have been able to build contacts and relationships with other responders and agencies and learn to rely on each other for help during incidents and exercises/training events as well as bringing back the knowledge they gain and sharing it with colleagues. Nye County LEPC is requesting to send approximately 15 attendees to the 2022 FSW Conference and Expo in Reno, NV, currently scheduled for September 26-29, 2022. The requested funding will cover conference registration, hotel rooms, per diem and mileage. In order to minimize expenses, we will request as many double occupancy rooms as we can, attendees will carpool whenever possible, and use County/Agency transportation to the fullest extent possible.





# SA2 Unintended Outcomes: Breaking the Cycle 8:00 am

Timothy Kelly

In 2018, Los Angeles City Battalion Chief Tim Kelly and a crew of firefighters survived a burn over and entrapment while fighting the Mendocino Fire. The Mendocino Fire remains the third largest wildfire in California's history, burning nearly a half-million acres of the Mendocino Forest.

During firing operations, Chief Kelly and his crew were cut-off from their escape route by an immense crown-fire burning rapidly through the timber at the fire's massive front. Chief Kelly will walk attendees through the chilling experience of the entrapment, detailing the sights, sounds and actions in that crucial moment. Participants will get a firsthand sense of what it was like to be caught in a burn-over of this magnitude, including the chaos and confusion that ensued as firefighters made their harrowing escape. He will discuss the leadership that surfaced amongst the crew in those pivotal seconds of being faced with a life-or-death situation.

The course will include a comprehensive review of the U.S. Forest Service Facilitated Learning Analysis to help highlight some of the larger incident management challenges, strategic and tactical decisions, environmental conditions and human factors that played a key role in the chain-of-events that day. From the supervisor and crew level, Chief Kelly will highlight some of the physical, psychological and structural barriers that challenged the decision-making process and helped to set the stage for the unintended outcome.

When actions and decisions deviate from policies and procedures, either intentionally or unintentionally, devastating effects can occur. An examination of some of the critical decisions leading up to the firefighter entrapment will emphasize this point and drive discussions on methods to avoid the same trap, as well as how to remain disciplined in fast paced and high pressure situations.

A case study of a subsequent wildland fire in northern California will be presented to demonstrate how the lessons of Mendocino were successfully applied under nearly identical circumstances and conditions. Lastly, Chief Kelly will reflect on the core takeaways from both incidents as a means for the fire service to further institutionalize a risk management mindset and create an anchor point from which to ultimately begin "breaking the cycle" of repeatedly learning the same type of lessons that result in unintended outcomes.

Unfortunately, however, we also possess certain traits, habits and even beliefs that often prevent us from reaching our true potential and experiencing life to the fullest.

Whether manifested in the form of a physical or mental limitation, an emotional or psychological affliction, or even an imagined encumbrance, such handicaps sabotage the pursuit of our goals and desires in ways that may be hidden to us. In this inspiring and impactful presentation, Dave Davlin shares how he identified and refused to be limited by his own obstructions—and reassures audiences that even though limitations exist in many forms, we do not have to be limited by them.

### HE1 First to Respond, Last to Seek Help 8:00 am

Dr. Stephen Odom and Chief Jamie Williams

First Responders become accustomed to exposure to acute trauma that eventually results in physical, mental and emotional exhaustion of the body and mind. In response to the high intensity of the job and the accumulation of traumatic stress injuries; concentration, judgment, sleep, and even relationships are negatively affected. Over time, alcohol or other substances often becomes a means of coping, leaving first responders at risk for developing an alcohol misuse problem along with mental health issues like post-traumatic stress injuries (PTSI), depression, or anxiety.

Dr. Stephen Odom presents an in-depth presentation that examines causes, signs and symptoms of post-traumatic stress injuries, and how it affects Fire Fighters and their families.

We will explore what can be done to heal, prevent further damage, and create a new "Brain Health" culture in which prevention and resiliency are trained into from the beginning of a career. Throughout the discussion, the effects of organizational culture and leadership are also examined & better understood, along with recommendations for creating a safe, confidential, and accessible Behavioral Care System for your Fire Service.

### HZ4 Table Top Command--Haz Mat Mobile – 4 Hours 8:00 am

This program uses a miniature table-top city to perfect the participants incident command skills and assign resources using ACT objectives. Over the years we have used the Table Top Simulator for Structure Fire simulations at Fire Shows West. This year we will be conducting the Haz-Mat Module.

The session objectives are to increase the slide carousels that we use for decision making, have a better understanding of risk vs gain concepts and to prepare students to take command of an incident and assign resources. This course provides the tools a person needs to assume control of an emergency response to a hazardous materials incident. It focuses on how to assess hazards, manage risk, comply with legal requirements and implement protective actions. Basic Haz-Mat Training should be a prerequisite but not required.

The personnel pool for fire and EMS is shrinking affecting the number of persons interested in leadership positions. As first responders we respond and provide advanced levels of medical care in the field. As Firefighters and Paramedics, we spend hundreds of hours training for medical and trauma related incidents. Our training focuses on high performance execu-

tion of advanced life-saving treatments using every tool at our disposal in the field. Even with best efforts in saving a life, our highly skilled field providers do not always have positive outcomes. Ironically, it does not mean we did not perform flawlessly in our training.

The training that is missing is providing emotional first aid to the survivors and learning how to reset and recover ourselves from this very personal experience. We often struggle transitioning from the high performance "technical mode" where we disassociate from the human aspect of our jobs to remain shared and focused.

Providing emotional first aid for survivors can be a traumatic experience for responders. One of the reasons for this is be-

cause they have little to no training in treating someone on that emotional level after an extreme loss. For example, a post cardiac arrest where resuscitative efforts were discontinued by orders of the on-line Doctor. The Captain or lead Paramedic must turn around and address the family member(s) in the room and deliver this difficult news. Where there was once hope, now is confirmation that their spouse, son, daughter, etc. is now dead.

This can be more difficult on an accident scene or house fire. The surviving family member is now dropped into one of the 5 stages of grief (anger, barraging, denial, depression, or acceptance). Anyone with some experience can tell you how scary it is when someone is in that stage of anger or rage expresses their loss externally. But it is an appropriate feeling

#### **KEY2** Emergency Management in the 21st Century

The role of the emergency manager is quickly becoming professionalized. We are moving from a workforce of committed individuals who are assigned to the emergency management role as part of their regular public safety duties toward those individuals who study emergency management in degree programs to serve their communities.

This movement is critical to our abilities to address the threats and hazards of today and tomorrow. We are seeing more complex disasters that engage more than just flooded out neighborhoods or the loss of a

dozen structures in the wildland interface. The complications of the response are just the tip of the iceberg of the overall recovery of the community. Disasters today require tomorrow's emergency managers to understand all facets of the disaster cycle and be able to provide this expertise to our community's elected and appointed leadership.

Chris will speak about the technical evolution of the comprehensive emergency manager and the role of this professional as a part of the public safety team in a community that works together to help people, before during and after disasters. In addition, he will address the benefits of these members of our public safety teams and help to articulate there is a lot to do in this space given the intensity and frequency of disaster, the politics and economics of disaster as well as the role of government and voluntary organizations active in disaster.

and sometimes that's not understood by the responder. Secondary trauma to the survivor or next of kin is an easy pothole to step into without having emotional awareness. Knowing what to say or what not to say can be a tightrope walk for our responders who have not had training in this subject.

Reset and recovery of the first responder after this incident is not found in avoiding, suppressing, or numbing that experience. It is found in healthy and open dialog with a peer. Mindfulness of the experience and processing it before moving one. This could be someone within the department or an outside confidant that understands the job. This someone would also know the higher-level resources that are available.

# HZ5 Chemical Hazards Determination Using the Wet Chemistry Hazard Classification Procedure 1:30 pm Randy Perlis
