## NOTICE OF INTENT TO ACT UPON A REGULATION

Notice of Hearing for the Amendment of Regulations of the State Emergency Response Commission

The State Emergency Response Commission (SERC) will hold a public hearing at 10:30am on December 13, 2022, at 107 Jacobsen Way, Classroom C, Carson City, NV 89711. The purpose of the public hearing is to receive comments from all interested persons regarding the Amendment of regulations that pertain to Chapter 459 (459.9912 – 459.99189) of the Nevada Administrative Code.

The following information is provided pursuant to the requirements of NRS 233B.0603:

### 1. The need for and the purpose of the proposed regulation.

LCB file R059-22P: The proposed regulation is to: define the Legislative Committee, Policy Committee, Radiological Committee; clarification of the Bylaws Committee duties; replacing and/or updating words in text; clarifying and/or simplifying language; and clarification of collection process.

# 2. Either the terms or the substance of the regulations to be amended or a description of the subjects and issues involved.

Areas in the regulation for amendments are:

Section 1 Chapter 459 - "amended by adding thereto the provisions set forth as sections, 2, 3 and 4 of this regulation"

NAC 459.99121 - "Bylaws Committee"

NAC 4529.99123 - "Emergency Plan"

- NAC 459.99132 "Local emergency planning committees: Administrative duties"
- NAC 459.99133 "Emergency plans: Establishment, review and approval; correction of deficiencies; failure to comply"

NAC 459.99141 - "Requests for money from proceeds of certain fees to pay for training"

NAC 459.99163 – "Requests for money from proceeds of certain fees to pay for training"

NAC 459.99183 - "Failure to pay required fee when due"

NAC 459.99189 - "Appeal of decision of Commission or staff member of Commission"

NRS 459.742 (1) "Enter into contracts, leases or other agreements or transactions."

NAC 459.99135 Authority of Commission: Grants of money from Contingency Account for Hazardous Materials. (NRS 459.735, 459.740) Pursuant to NRS 459.742 an in accordance with the provisions set forth in NAC 459.99138 to 459.99146, inclusive, the Commission may: (1), (2), (3) ".....issue grant to local emergency planning committees....."

NAC 459.99161 Authority of Commission: Allocation of money from Contingency Account for Hazardous Materials. (NRS 459.735, 459.740) Pursuant to NRS 459.742 and in accordance with the provisions set forth in NAC 459.99138 to 459.99146, inclusive, the Commission may: (1), (2), (3) ".....Allocate.....to state agencies....."

### 5. The estimate cost to the agency for enforcement of the proposed regulation.

There will be no cost to the agency for enforcement of the proposed regulations.

6. A description of and citation to any regulations of other state or local governmental agencies which the proposed regulation overlaps or duplicates and a statement explaining why the duplication or overlapping is necessary. If the proposed regulation overlaps or duplicates a federal regulation, the notice must include the name of the regulating federal agency.

There are no overlaps or duplications of other state or local governmental agencies or a federal regulation.

Written submissions must be received by the State Emergency Response Commission on or before December 9, 2022. If no person who is directly affected by the proposed action appears to request time to make an oral presentation, the State Emergency Response Commission may proceed immediately to act upon any written submissions.

A copy of this notice and the regulation to be Amended will be on file at the State Library, 100 Stewart Street, Carson City, Nevada, for inspection by members of the public during business hours. Additional copies of the notice and the regulation to be Amended will be available at the State Emergency Response Commission, 107 Jacobsen Way, Carson City, NV 89711, and in all counties in which an office of the agency is not maintained, at the main public library, for inspection and copying by members of the public during business hours. Copies of this notice and the proposed regulation will also be mailed to members of the public upon request. A reasonable fee may be charged for copies if it is deemed necessary.

Upon adoption of any regulation, the agency, if requested to do so by an interested person, either before adoption or within 30 days thereafter, will issue a concise statement of the principal reasons for and against its adoption and incorporate therein its reason for overruling the consideration urged against adoption.
