The source of funding is derived from fees collected from the sale and annual renewal of United We Stand specialty license plates. As these are State funds, there is no Catalog of Federal Domestic Assistance (CFDA) number associated with this allocation.

The allocation project period is expected to be July 13, 2024, to June 30, 2025. Allocation funds are distributed on a reimbursement basis; however, the State Agency may request advance funding for expenses over \$2,000, policy 8.5.

State Agencies are eligible for funding through this allocation if they are in compliance with the head of the State agency prioritizing the request and signing the allocation application, certified assurances and allocation award; identifying if the agency falls under an emergency response plan and its role in the plan; identifying its role, if any, in the State Comprehensive Emergency Management Plan; identifying any response capabilities on the Level of Response Questionnaire. Policies may be found on the SERC website, <http://serc.nv.gov>.

The application must include justifications of use of funds to support preparedness to combat terrorism - NRS 202.4415 defines acts of terrorism.

Pursuant to SERC policy 8.2a, the allocation application must address one or more of the Nevada Commission on Homeland Security priorities available at <http://serc.nv.gov>.

The goal of implementing surveillance systems by the Nevada Legislative Police is to create a secure environment that fosters the smooth functioning of Legislative proceedings while prioritizing the safety and well-being of all individuals present within the Legislative premises. We are seeking funds to purchase the following:

Priority #1 Twelve PTZ, In-Ceiling Cameras and Eight metal In-Ceiling tile mounts. Surveillance systems equipped with PTZ (Pan-Tilt-Zoom) cameras play a crucial role in promptly monitoring key areas within Legislative premises, empowering security personnel to assess unfolding situations, including potential terrorist incidents. The live video feeds from these cameras facilitate informed decision-making and enable quick resource allocation to effectively counter terrorism threats.

This proactive measure protects against terrorist threats aimed at disrupting governance or compromising security, thereby enhancing overall preparedness. Moreover, the captured footage from the proposed cameras serves as invaluable evidence for identifying perpetrators, deciphering their tactics, and potentially uncovering any accomplices or networks involved in terrorist activities. This comprehensive surveillance approach strengthens security measures and aids in preventing future threats to Legislative safety and integrity.

- **Intelligence Information and Information Sharing**

The equipment requested in this grant application will help the Legislative Police and the surveillance team to effectively collect, analyze and disseminate information data. The upgraded cameras will enhance the video quality of captured images, thus supporting the need for improved and expedited facial recognition at main entrance points. The objective is to enable the Legislative Police to analyze intelligence information for the sharing, prevention, and resolution of criminal/terrorist activities.

The new cameras will also aid the Legislative Police in the development of terrorism-related prevention activities. With newer cameras, the Legislative Police will be able to expeditiously provide vital information and improve operation coordination with local, state, federal and tribal agencies.

- **To equip state and local agencies and emergency officials with the necessary equipment and facilities to improve and maintain performance objective advancing whole community security and capability.**
- **To create a safer environment through surveillance and to increase our capability of identifying suspicious individuals through law enforcement bulletins, intelligence sources and our own police officers' study of observed behaviors.**

The procurement of PTZ cameras by the Legislative Police signifies a notable advancement in their ability to safeguard legislators, Legislative staff, and individuals conducting official business at the Legislative Counsel Bureau. These cameras play a pivotal role in achieving the outlined objectives:

With the acquired PTZ cameras, the Legislative Police can effectively identify potential threats, whether originating domestically or internationally, within the Legislative properties. Through remote control of the cameras' pan, tilt, and zoom functions, the officers can conduct comprehensive surveillance in real-time. This enables them to promptly detect suspicious individuals, unauthorized access attempts, or unusual activities, thereby enhancing security measures.

Moreover, PTZ cameras serve as valuable tools for capturing video evidence of suspicious subjects entering Legislative premises. The high-resolution footage obtained can be instrumental in documenting the movements and actions of individuals of interest. This evidence can then be provided to other law enforcement agencies for further investigation and legal proceedings. The cameras' ability to zoom in and track subjects ensures the production of clear and detailed footage, enhancing the efficacy of investigations.

By strategically installing PTZ cameras throughout Legislative properties, the police gain enhanced situational awareness of their surroundings. They can monitor multiple areas simultaneously and respond to security incidents promptly, minimizing risks and ensuring a secure environment for all individuals within the premises. Integration with existing security systems further strengthens the overall security infrastructure, enabling seamless coordination and effective response to security threats.

In summary, the acquisition of PTZ cameras empowers the Legislative Police to identify threats, provide video evidence to law enforcement agencies, enhance situational awareness, and integrate with existing security systems effectively. By leveraging the capabilities of PTZ cameras, the Legislative Police can bolster security measures and ensure the safety of legislators, staff, and visitors within Legislative properties.

Upon acceptance of funding from the State of Nevada Emergency Response Commission (SERC), the applicant and the lead governmental unit hereby agree to the following Certified Assurances governing the awarding of funds:

- A) The recipient assured compliance with the Nevada Administrative Code (NAC) 459.9912 et seq. and SERC policies found at <http://serc.nv.gov>.
- B) **FINANCIAL REPORTS** – The recipient is required to submit, at a minimum, a quarterly financial report to the SERC. Reporting must be made in accordance with all applicable federal, state, and local laws and regulations, and SERC Policies 8.5 and 8.6.

No expenditures or obligations will be eligible for reimbursement if occurring prior to or after the award period. All funds need to be obligated by the end of the allocation period and expended by the final report date as stated in the allocation award cover letter. Failure to submit proper reports pursuant to current policies may jeopardize future funding from SERC.

- 1) **Request for advance:** May be requested only if expenses total over \$2,000.00 and are accompanied by a dated purchase order or quote. Complete and submit a financial report form with the appropriate “request for advance” box checked.
- 2) **Report on expenditure of advance:** Show the actual expenditure of the advanced funds. Complete and submit a financial report form with the appropriate “report on expenditure of advance” box checked. This report is due **within 30 days** of the date of the advanced check and must include copies of dated invoices and proof of payment. If the amount advanced is more than the amount spent or the advanced amount is not spent within the 30 days, the unexpended funds are to be returned to the SERC within 45 days of the date of the check.
- 3) **Request for reimbursement:** Complete and submit a financial report form, at a minimum quarterly, for all expenditures funded by the allocation. Include a summary breakdown of expenses, copies of dated invoices, proof of payment and any other documents required by SERC policies. Any other form of documentation for expenditures must be approved by the SERC staff. If additional funds are used toward the project, report those expenditures as a **match** in the appropriate line on the report form.

- 4) **Quarterly report required:** If there are no expenditures within the quarter, a report with an explanation of why and the plan for future expenditures is due by the end of the month following the end of the quarter. Due dates for quarterly reports are as follows:

October 31 - for reporting period July 1 to September 30.
January 31 - for reporting period October 1 to December 31.
April 30 - for reporting period January 1 to March 31; and
July 31 - for reporting period April 1 to June 30.

- 5) **Final report:** There will be no further expenditure, the allocation is closed, and no further reports are necessary. This report is due within 45 days after the end of the award period, or any time prior to the end of the award period if no further funds are spent.
- C) **CHANGE REQUEST** – Allocation expenditures are authorized for the purposes set forth in this application, as approved in the allocation award, and in accordance with all applicable laws, regulations, and policies and procedures of the State of Nevada and the applicable federal granting agency. Request for change in the project must be submitted to the SERC and approved in writing prior to its implementation. Approval may be required by the Funding Committee if the change is significant (SERC Policy 8.7).
- D) The recipient assures, through the submission of the application for funding, neither the lead agency, county government nor any of its participating agencies are presently debarred, suspended, proposed for debarment, declared ineligible, or voluntarily excluded from participation in the transaction by any federal department or agency.
- F) The recipient assures the fiscal accountability of the funds received from the State Emergency Response Commission will be managed and accounted for by the lead agency's chief comptroller and internal control and authority to ensure compliance with SERC's documentation, record keeping, accounting, and reporting guidelines will reside with that individual.
- G) SERC will reimburse the recipient reasonable, allowable, allocable cost of performance, in accordance with current federal requirements, Nevada Revised Statute, Nevada Administrative Code, State Administrative Manual, SERC policies and any other applicable fiscal rules, not to exceed the amount specified at the total award amount.

- H) The recipient assures it shall maintain data and information to provide accurate financial reports to SERC. Said reports shall be provided in form, by due dates and containing data and information as SERC reasonably requires administering the program.
- I) The recipient assures financial reports shall be submitted within 30 calendar days of the end of each calendar quarter and within 45 days of the end of the project period and shall be current and actual.
- J) The recipient assures funds made available under this allocation will not be used to supplant state or local funds.
- K) The recipient assures that it will comply with applicable federal cost principles and administrative requirements appropriate to the allocation as follows:





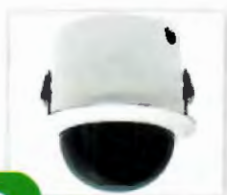
