Do I have any public comment?

Hearing no public comment, I would like to mention that I mentioned this at the, State Fire, excuse me at our SERC meeting last week, but I'd like to mention Bailey and BrandiLynn have some personnel issues and so we haven't had them on SERC for almost a month now and I want to extend my thanks to Mike Dzyak, the State Fire Marshal and Kelly is an assistant to Mike and Ashley, also the Kelly and Ashley have been wonderful to work with and keeping the funding committee and the SERC Commission up and running while we're going through this process.

We don't have much information to give you in reference to what's going on there, but I just want to extend my thanks to the fire Marshal's office for your help.

If there's no other public comment, we'll go to item number four, which is approval of the April 10th, 2025, minutes at present time.

Kelly, fill me in if it changes. Last time we talked, Kelly and myself, Kelly was still looking for the meeting transcript or the voice so she could do the Minutes of the meeting and she's I don't believe you have that right, Kelly.

OK.

OK. The one big thing on that meeting was that we went through all the SERC OPTE Grants and we approved all of them and made recommendations to the SERC to approve them and there was one grant that Karen Luna made a motion, and I second it, and it was White Pine County. They were requesting some sparkless tools, and they're only trained at the operation or excuse me, the awareness level.

I have reached out to White Pine County and spoken with their LEPC Chair and he's getting me in touch with their Fire Chief so we can figure out exactly how they're going to use those tools, and the motion was that the Co-chairs would resolve this issue for the equipment. So, I just want to give you that update, but right now we don't have any minutes to approve so I'm going to move on to item number 5, which is the bulk of our meeting today.

This is a review of the United We Stand Grant applications. Thank you, Kelly and Ashley for putting that spreadsheet together. I don't know if everybody's seen the spreadsheet, but it's very, very useful.

It looks like we've got a really a whole bunch of them, but they did a nice job. There was one county, Lander County, that it was not quite the information I wanted to see, so I reached out to them and they've reached out to Kelly and sent her a new one. So I'm happy with that and we'll get started here. I know we have a number of people on the phone. Does anybody have any concerns or would they like to start with theirs first because there's time crunch and by the way, Kelly, I'm gonna ask you before we get started with this, the first thing We the funding committee always asks do we have enough money? So that we can basically cover all these grant requests.

They're gonna be obtaining communications equipment. The objectives were filled out nicely. Also, the priorities the United We Stand priorities were identified.

I'll go ahead and make a motion that we fund their application as provided to us and I'll make a general comment as well and that's I share your opinion, Richard, that this was a very good set of applications. Most of the locations gave us good information.

I don't have the newer Lander County information, but if their amount hasn't changed I'll have to rely upon others to have seen their application.

The motion carries unanimously.

Next grant up is Clark County.

Clark County is looking for some training, some supplies and equipment.

They totaled \$32,000. They talked about in their goals. Assisting jurisdictions in combating terrorism, which is good. They discussed a number of looks like 5 different projects that they're working on.

Their objectives? The Who, what, when, where were identified?

You know, they also did a good job talking about the United We Stand priorities, so operational coordination.

Kelly, do you have anything to add to in reference to Clark counties?

They had a couple of things that they sent in that were not on their budget line item.

So that is just a question I had about that because it wasn't mentioned on.

Their budget of equipment. As per the price.

I would think they would. We would want that on there for auditing, would we not, Kelly?

**KH Kelly Hutter** 13:22

Yes. And so, I've had that question, I'm waiting to find out about that.

**RB Richard Brenner** 13:29

OK. Yeah, they should have that on there and then because of the training they got did they receive a letter from the State Fire Marshal's office too.

Yes, I already.

Good.

I got that. I walked over there and got that three buildings down.

The next county is Douglas County. Douglas County is requesting \$32,000 in equipment. Umm.

Their goal statement mentions about potential terrorist incidents. They are looking at getting a drone. The UAS. Getting some radios.

They do have their communications questionnaire completed.

Thank you, Kelly. Yep. Good. All right.

And then some new Brinc ball, a new wireless technology. OK.

For negotiating, OK. And then their objectives.

The Who, what, when? It's all there and I like what they did there.

They did it really well. Operational coordination, operational communication, they identified the priority for all three. And Kelly, did they have anything else that was outstanding?

I know that they didn't. All their stuff and quotes and everything matched.

Good. Perfect. Looks good. OK, would someone like to make a motion in reference to Douglas County?

Probably I hate to take bulk of these, but I'll go ahead and make a motion that we recommend to the SERC they approve the this grant application as provided to us.

Lance Chandler I'll second. And you're doing a great job, Susan.

Elko County.

Their goals. They're looking at the Starlink system for satellite communications, self-contained breathing apparatus, bottles and self-contained breathing apparatus mask. They have The Who, what and when filled out.

And they talk about communications as their priority and PPE and so.

Kelly, is there anything you'd like to add in reference to this?

They also have their communications questionnaire completed.

OK.

**KH** **Kelly Hutter** 17:51

And explained.

Perfect.

Alrighty then.

And they're asking for it looks like almost \$31,752 is what they're requesting.

Do I hear a motion to approve this?

This is Susan Crowley.

I'll make a motion in a second, but I I'd like to ask a question. Just a general question.

The Starlink system seems like it would be a good piece of equipment for many of our emergency response vehicles that travel to emergencies.

Do we have many that are out there yet or already?

**RB** **Richard Brenner** 18:41

I Rich this, Susan, this is Richard.

I don't believe so, his is the first time I've seen it on the grant process that I can remember and I agree with you.

It's new technology and being a fisherman and seeing the arrays over my head.

Late night with the 25 lights flying over and in talking with the Lander County, I mean, they're their Wi-Fi system and their Internet service provider was out, and they

couldn't do anything on their computer yesterday. So as a backup, I mean this would be a fantastic idea. So, you're absolutely right, Susan. This is, I think we're going to see more of this.

Well, I'm hoping we can kind of keep track of how, how well or how poorly it does so that we can know how to talk with our LEPC's about and their emergency groups, about possibilities. So I'll make a motion that we approve their application as provided to us.

This is Gil, just to follow up with Susan, we at the company I work for, we use Starlink extensively and most recently we had a pretty major hurricane back east at one of our facilities and was able to keep full functionality using Starlink. So, it is an excellent tool.

That's really good news. Thank you.

Gil, can I ask you a question? This is Richard.

Is it expensive when we when I was with the fire department, it was costing me close to about \$5000 a year to keep our satellite provider is it cheaper than that?

Give you a bad answer, Richard.

I can't tell you how much it costs. There is a monthly fee, so there's the purchase, the equipment, and there's a subscription. You have to pay each month for the service.

That's well, we'll keep following it.

Thank you, Gil for the feedback.

And if I remember, we were just getting ready to vote on this.

There we go, Humboldt County, and they're requesting \$31,985.

It's all equipment. Going to their area for their goals.

They do talk about terrorism in their request, which is good. PPE.

Tri-county Special Response team equipping them.

They've got two specific goals that they're looking at equipping operators with high risk operations with protective equipment and utilizing ramp funds for ballistic vest protection rifle plates and then Tactical units 24 hours, OK.

So it's PPE, the equipment for law enforcement, emergency medical service and fire personnel. OK, good.

For their objectives. They did identify.

I who is gonna purchase everything and when it will get done and how it will get done?

And for their priorities, they identified intelligence and information sharing. So good.

Alrighty Kelly, is there anything you like to add in reference to Humboldt County's request?

OK.

Because we usually see that on the spreadsheet.

Yes, all counties are.

The staff at the Fire Marshal's office, Lance, has been phenomenal and kept in going through the grants and sending them back and making him change stuff.  
So again, kudos to Kelly and Ashley, Lance. They they've really saved us a lot of time.

Absolutely. But we've seen that in the past and I just wanted to make sure we weren't missing something.

Thanks for bringing it up.

So, since want to change it around a little bit, Lance, you want to make a motion for Humboldt County?

All righty. The next county up is Lander County and Lander County. They were requesting \$36,460. This is one of the reasons why I called and explained to them that, you know, we only can give them \$32,000. In their goal statement they talk real well about the LEPC and but they really don't identify what their goal is so I asked him to state exactly what they want to purchase under the goal statement and make reference to because of and they don't mention anything about terrorism in their goal statement or preventing terrorism or being prepared for a terrorist incident. So,

they did write a little paragraph in there. The 4th bit of 4th paragraph, you know, stating when you have a terrorist event. It's a high crisis situation with lots of stress and people can have heart attacks. The piece of equipment that they're requesting is this Chest compression system for doing CPR for their ambulance. So, they do have the paragraph in there now.

Under objectives, they do discuss The Who, what and when, when they're going to purchase this equipment.

Under the priorities, they did not have the priorities identified. They've got 2 repair or three paragraphs there, but they did not identify which priority this would fall under. So they have identified that priority operational considerations that for so that's in there and those were the things that I identified with this grant. They are expecting, they're hoping that they're gonna get some money back when they turn in some items so that they can actually be in the \$32,000 range. Rather than being higher, but they don't know if that's gonna occur or not.

So I saw it in their quotes that they mentioned that.

Does anybody have any questions or comments in reference to Lander County?

Kelly, is there anything you'd like to add in reference to it?

**KH Kelly Hutter** 27:27

No, I just. I'm glad you mention it because it wasn't on their budget about the \$10,000 refund, so. Yeah, that would take them down to almost 30,000. If they do get a refund.

**RB Richard Brenner** 27:41

Exactly. And that's all known perfect.

It's, you know, if it happens.

I hope it does. If not, then you at least buy one.

OK.

Would someone like to make a motion in reference to Lander County?

**SC Susan Crowley** 27:56

This is Susan Crowley.

I'll make a motion that we recommend to the SERC that they grant they approve the grant as amended, and that Richard has been talking about.

Up to 30 up to 32,000.

**RB** **Richard Brenner** 28:15

Do I have a second?

**LC** **Lance Chantler** 28:17

Lance Chandler.

I'll 2nd.

**RB** **Richard Brenner** 28:19

Thank you.

Discussion.

Hearing nothing. I'll call for the vote.

All in favor, please say aye, aye.

Any opposed. The motion carries unanimously.

The next county up is Lincoln County. Lincoln County is requesting 31,830 dollars.

They their goal statement. They do talk about terrorism activities and enhancing first responder protection. They're looking for atmospheric monitors and what else?

I thought they had. Oh, and replacing some PPE turn out gear was another thing.

So those were the two things on that. Two requests under their objectives.

It talks about who and when and what will happen, so that was good.

They're United We Stand priority is identified operational coordination, which is good.

Kelly, is there anything you'd like to add in reference to this? This grant application for Lincoln County?

Not at this time, but I do like the equipment they're requesting because I know firefighters that probably would have wished they had it.

Yep, no, it's good.

They're modernizing, though. It's good.

They talk about how it looks like they're wanting to purchase equipment Night vision. Binoculars and binoculars, Thermal imaging stuff, OK.

Under objectives, they do identify who's going to be purchasing it when and what?

From the priorities they do identify operational coordination for the priorities. So nope, this is good. Kelly, anything you want to mention in reference to this grant application for Lyon County.

They do talk about counter terrorism operations, which is good. I'm glad they put that in their goals. Looking at 7 thermal imaging cameras for their patrols.  
Cars for the Sheriff's Office talks about when. OK, that's good.  
For preparedness tools, OK, I don't have any issues with this grant request, Kelly.  
Is there anything you'd like to add in reference to Mineral County?
